When a person seeks care at OHIO Specific Chiropractic and when Dr. Jarek accepts a patient for such care, it is essential that they are both seeking and working toward the same goals. Chiropractic has one goal. It is therefore important that you understand the goal and Dr. Jarek's means to attain it. In this way there will be NO confusion, misunderstanding or disappointment.

First, you must realize that Chiropractic is NOT a substitute for medical treatment of any kind, in any way, for any reason. Also, NO statement by Dr. Jarek Esarco is intended to be a medical diagnosis and should not be confused as such. Patients usually want to get rid of whatever ailments, symptoms or conditions are bothering them. This, however, is NOT the foundational goal of Dr. Jarek. Chiropractic is not intended to be a treatment of the symptoms of a medical condition or treat the cause or causes of a medical condition.

The purpose of this Chiropractic procedure is to restore and maintain the integrity of the nerve system at the brainstem level. The brainstem is the vital control center of the nerve system and is housed in and protected by the atlas and axis bones of the spine. A misalignment between the two top bones of the neck and the base of the skull can interfere with the functional information and mental impulse coming from this delicate nerve tissue. This is called a vertebral subluxation. A vertebral subluxation can come from many causes and prevent various organs, glands and tissues from functioning properly.

The goal of Chiropractic is to adjust the vertebral subluxation for the purpose of allowing the proper transmission of mental impulse to occur from the brainstem and transmit over the nerve system so every part of the body may have a proper nerve supply at all times. This allows the innate healing ability of the body to work at maximum efficiency. With a properly functioning brainstem, health improves. In some, symptoms clear up quickly. In others, the process is slower, and in some, it is only partial or not at all. Regardless of what the disease is called, Dr. Jarek Esarco does not offer to heal or even treat it. Your body alone has the potential to heal. Nor does he offer advice regarding the treatment of disease. His only goal is to allow the body to do its job. His only means is the adjustment of a vertebral subluxation. He promises no cure from and offers no treatment of disease. The information we receive from you is important.
